## All-Ohio Symposium 2023 Partner Agreement

By signing up for a partnership, you agree to the following regarding your partnership of the All-Ohio 2023 Symposium.

- 1. Conference Space: We understand that sponsorship is on a first-come, first-served basis. Our application will be considered complete when our signed partner application, logo, and payment are received. Upon processing, we will be notified that our application has been approved.
- 2. Partner Protocol:
  - a. Our company materials will be confined to the four- or six-foot draped table.
  - b. We are responsible for set-up and removal of our promotional materials. At our expense the venue may provide additional services (such as additional AV, return shipping).
  - c. We understand that we will set up an account with the hotel to cover the cost of their receiving our shipped materials.
  - d. We understand that the exhibit hall is not secure and that we assume sole responsibility for security of items left at our exhibit table.
- 3. Cancellation and Unforeseen Events
  - a. We understand that we may submit a written request for cancellation by July 1, 2023. The Conference will refund our sponsorship payment less \$1,000 to cover costs incurred. We understand that, due to conference legal and financial commitments, sponsor cancellation requests submitted after July 2, 2023, are not eligible for a refund.
  - b. We understand that the Conference Committee reserves the right to modify or cancel the Conference due to events such as strikes, natural disasters, disruptions in the transportation network, or other unforeseen events which make it impossible or inadvisable to hold the Conference.
  - c. We understand that, if Conference cancellation occurs, the Conference Committee cannot guarantee a refund of our sponsorship payment.
- 4. We understand that the FPA All-Ohio Symposium Committee must accept our sponsor application.
